PC Foundation spells out mission

Board members chosen for business acumen, resources

Earlier this summer, board members of The Park City Foundation gathered on Main Street at the East West Partners office for a day long retreat. After almost a year under the leadership of Executive Director Trisha Worthington, the organization focused on strategic planning. The result was a defined vision for the next three years and shared approach to philanthropy and growth.

"The retreat was a fantastic opportunity for our new board to share their philanthropic experiences, knowledge, and expectations with one another," commented Worthington. "We walked away with a shared approach to creating

a Foundation that serves the Park City community- its donors and its nonprofits." The result was five guiding goals over the next three years:

- Promote Philanthropy- Raise awareness of the role of a community foundation by encouraging impactful, creative and strategic giving.

- Endow our Community's Future- Identify and recruit untapped donor resources to build a broader, sustainable asset base.

- Strengthen Nonprofits- Provide our nonprofit partners with innovative services, sophisticated support and diverse funding options.

- Build a Solid Foundation- Develop the organizations systems, services and relationships to create a sound foundation for Park City's future.

- Engage in Innovative Leadership- Foster collaboration to identify, address, and focus our community on unmet needs and

long term challenges.

The retreat was facilitated with the expertise of two visitors: Colleen Mendel of T/TAS, a non-profit consulting group and Robin Reiter-Faragalli of Reiter & Associates, a corporate and family foundation consulting firm. Reiter, travelling from Miami, brought her community foundation expertise and national philanthropic knowledge to the board retreat. Mendel, a Park City local, built on her earlier work with the organization's mission and value process to guide the strategic planning segment.

"I enjoyed our consultant Robin who share her vast experience and inspired the discussion for our board in addressing pertinent issues and provoked clarity around early initiatives we were considering," commented Grants Committee member Susan Graham Mayo.
